

Parent/ Legal Guardian Payment Contract

If the student is under the age of 18 when reading and agreeing to the Terms and Conditions of the Student Financial Agreement, one of the student's parents or legal guardian must also a "Financial Agreement". By singing this contact, you agree to following Terms and Conditions:

PAYMENT OF FEES/ PROMISE TO PAY

I understand that when my child registers for any class at The International School of Business Entrepreneurship & Technology (ISBET) or receives any service from ISBET I accept full responsibility to pay all tuition, fees and other associated cost assessed as a result of my child's registration and/ or receipt of services. I further understand and agree that my child's registration and my acceptance of these terms, constitutes a promissory note agreement.

DELINQUENT ACCOUNT/COLLECTION

Financial Hold: I understand and agree that if I fail to pay my child's account or any monies due and owing ISBET by the scheduled due date, ISBET will place a financial hold on my child's account, preventing them from requesting transcripts, or receiving a diploma.

LATE PAYMENT CHARGE:

I understand and agree that if I fail to pay my child's account or any monies due and owing to ISBET by the scheduled date, ISBET will assess late payment and/or finance charges of at the rate of 5% or a minimum of \$100 per month on the past due portion of my child's account until the past due account is paid in full.

COLLECTION AGENCY FEES:

I understand and accept that if I fail to pay my child's account or any monies due and owing ISBET by the scheduled due date and fail to make acceptable payment arrangements to bring my child's account current, ISBET may refer his/her delinquent account to a collection agency. I further understand that I am responsible for paying the collection agency fees which may be based on a percentage at a maximum of 40% percent of their delinquent account, together with all cost and expenses, including reasonable attorney's fees, necessary for the collection of the delinquent account.
